## LEGAL REFERENCES FOR DATA PROCESSING

### Obligation of notification that arise out of the beginning of the membership based on Art. 13 and 14 DSGVO

#### 1. Name and contact information of the responsible party for data processing, as well as of the operational data protection officer

#### 2. Elevation and storage of personal data, as well as nature and purpose of their usage

When a membership is applied, we collect data such as the following:

- Titel, given name, surname
- Address
- valid E-Mail address
- valid phone number
- Social media handles (for competition registration)
- Information relevant for a membership of the association
- Information relevant for the participation of a competition of the association

The elevation of this information is carried out

- To identify you as a member of the association
- To represent you as an athlete on the social media channels and website of the association and its partners
- For communication with you
- For invoicing you

The data processing is carried out based on your application and according to Art. 6 Abs. 1 S. 1 lit. b DSGVO it is needed for the mentioned purposes for an adequate membership and for the mutual fulfillment of obligations out of the membership.

The personal data collected from the membership application will be saved up until the legal retention obligation ends (10 years after the termination of the membership). It will then be deleted unless according to Art. 6 Abs. 1 S. 1 lit. c DSGVO we are obligated to save them for a longer period either because of fiscal and commercial retention and documentation obligations (based on HGB, StGB or AO) or because you have agreed to a longer storage according to Art. 6 Abs. 1 S. 1 lit. a DSGVO.

### **3. Information Disclosure to a third party**

There is no disclosure of your personal data to a third party other than for the purposes mentioned is not.

According to Art. 6 Abs 1 S. 1 lit. b DSGVO, if this is needed for a process in relation with the membership, your personal data can be disclosed to a third party. This includes in particular the disclosure to partners of the association and other public authorities for the purpose of communication. The disclosed data is only allowed to be used for the mentioned purposes.

### **4. Rights of the person affected**

You have the right:

- According to Art. 7 Abs. 3 DSGVO to withdraw your once approved consent against us. This results in us discontinuing the data processing that was based on this particular consent.
- According to Art. 15 DSGVO to request information about the personal data processed by us. In particular, you can request information about the purposes, categories of personal data, categories of recipients that received or receive your personal data, the planned storage duration, the right of adjustment, deletion or limitation of the data processing, as well as the contradiction, the right to complain, the origin of your personal data unless not processed by us, as well as a automatic decision making incl. profiling and potential information for details
- According to Art. 16 DSGVO to request the immediate correction of wrong information or completion of the saved personal data.
- According to Art. 17 DSGVO to request the deletion of personal data saved by us unless the processing is not needed in the exercise of the right of the freedom of expression or information for legal obligation based on the public interest or as to claim compensation, practice or defence of legal claims
- According to Art. 18 DSGVO to request the limitations of the processing of your personal data as far as the correctness of your personal data is in denied or the processing is incorrect even though you refuse the deletion and we no longer need the data, but you need them to claim compensation, practice or defence of legal claims or according to Art. 21 DSGVO you file an objection against the data processing

- According to Art. 20 DSGVO to receive your personal data that you provided us in a structured, common, machine-readable format and to request a transfer to another responsible party and
- According to Art. 77 DSGVO to complain at a regulatory authority. Usually you can turn to your local regulatory authority or to the one local to the association.

## 5. Right to object

As long as the processing of your personal data is based on the interest of Art. 6 Abs. 1 S. 1 lit. f DSGVO, you have the right to object the processing of your personal data according to Art. 21 DSGVO as far as there are valid reasons that occur from your personal situation.
